Greetings in the name of our Lord and Savior Jesus Christ.

Praise the Lord, on April 26th we could start having services again. Naturally, guidelines were established, but we could meet. The excitement we felt was that of starting a new work. It was wonderful to see those few show up for the services, but it really was like starting over. With the sixweek service pause, many have not returned. Where we would have 40 in our Sunday evening service, now we were half that. On some Wednesdays, it would be just our family. You may say, that must be discouraging, and it can be. But we are excited for those that remain and for new first-time visitors that we have had. Our prayer, desire and goal is to be faithful.

In our last letter we mentioned that we did not have any Covid-19 cases in town. Unfortunately that has changed. Last count we had 137 cases. Things here seem to have taken off and all over Brazil. To our knowledge, no one from the church has gotten it, but some have relatives that have tested positive. There are guidelines set up for being out with social distancing, face masks and hand sanitizers. We have a plan that the city gives that we have to follow by and are in contact with the mayor's office. We try to follow that as best we can with all the guidelines so that people will feel comfortable attending services.

Two days a week, we go out in the late afternoon, leaving what you would call, door hangers house to house. I went to the mayor's office to make sure we could do this

without getting in trouble, and they said we could. So, we have a packet of 4 booklets that deal with salvation and repentance. One of the booklets is a John and Romans. What an opportunity to give hope during these days. Pray that God will continue to allow us this open
